





It is resolved that the college is following the rules governed by the collegiate education SOP



While enquiring, it was found that many students who are able to bring their lunch box also found that they have signed asking by forcefully by the leader.


So we have consulted the university SWO and the college management. As per their instruction, it was decided by the principal and Grievance cell allow them to lunch for their home if necessary.


